To protect the statutorily regulated confidentiality of your information, the Louisiana Department of Wildlife and Fisheries trip ticket data is made available only to the holder of the license for which information is requested. All information on this form must be filled in completely in order to obtain information from the LDWF Trip Ticket Program. This form must be presented in-person by the applicant to a representative of the Louisiana Department of Wildlife and Fisheries at its Baton Rouge Headquarters during normal business hours. See below for more details.

Landings data for individual commercial fishermen are provided as a complete listing by trip ticket for the time period indicated on the affidavit.

STEPS FOR COMPLETING A DATA REQUEST FORM:

2. Upon receipt of the completed form, we will process the information and contact you when your data is ready for pick-up. All information is processed on a first come, first served basis.
3. Proof of identity must be presented in-person by the license holder for the release of trip ticket data. Requests will be processed in the order they are received. When the data has been processed the applicant will be notified and he/she must sign for the receipt of records.

Once the applicant has been contacted by a representative of LDWF to pick up the data, the applicant must present the original form **in-person** to the LDWF Trip Ticket office located at:
